### NOTICE OF PUBLIC HEARINGS ON PROPOSED LOCAL LAWS

PLEASE TAKE NOTICE that two (2) Public Hearings will be held by the Board of Trustees of the Village of Lawrence at Lawrence Village Hall, 196 Central Avenue, Lawrence, New York 11559, on the 12<sup>th</sup> day of September 2019, at 8:00 PM, Eastern Standard Time. The Public Hearings are to consider the enactment of two (2) proposed local laws described as follows:

#### Proposed Local Laws of 2019

- 1) A Local Law to amend the Village Code §110-8-B and §144-5-B to prohibit construction and/or landscaping on the Federal Holidays of New Years Day, Martin Luther King Jr. Day, Memorial Day, Independence Day (July 4<sup>th</sup>), Labor Day, Thanksgiving Day and Christmas Day
- 2) A Local Law to amend the Village Code to prohibit the idling of all motor vehicle engines (within the Village boundaries) for more than 10 minutes

Copies of the proposed Local Laws described above are on file in the office of the Village Clerk of the Village of Lawrence, NY, where the same is available for public inspection during regular office hours.

PLEASE TAKE FURTHER NOTICE that all interested parties will be given an opportunity to be heard on said proposed Local Law at the place and time aforesaid. **If anyone needs special accommodations for a disability, such person should contact the Village Clerk at least 5 days before the public hearing.**

NOTICE IS HEREBY GIVEN, pursuant to the requirements of the Open Meetings Law of the State of New York, that the Board of Trustees of the Village of Lawrence will convene in public meeting at the place and time aforesaid for the purpose of conducting a regular meeting where general business will be conducted, and for the purpose of conducting Public Hearings on the proposed Local Laws described above and, as deemed advisable by said Board, taking action on the enactment of said Local Laws.
