### NOTICE OF PUBLIC HEARINGS ON PROPOSED LOCAL LAWS, 2018 – 2019 GENERAL BUDGET AND STORMWATER MGMT. REPORT

PLEASE TAKE NOTICE that four Public Hearings will be held by the Board of Trustees of the Village of Lawrence at Village Hall, 196 Central Avenue, Lawrence, New York 11559, on the 12<sup>th</sup> day of April, 2018, at 8:00 PM, Eastern Standard Time. The Public Hearings with respect to the following matters:

The enactment of Bill #2 a Proposed Local Law to amend Chapter 200 of the Village Code entitled "Vehicles and Traffic" (§200-50 Schedule XI: Parking Prohibited at All Times)

The enactment of Bill #3 a Proposed Local Law to amend Chapter 200 of the Village Code concerning placing school zone signage

The Annual Report to be filed by the Village for the year 2018 relating to the Municipal Separate Stormwater Sewer Systems (MS4) as to compliance by the Village with the Storm Water Management Program (SWMP).

In accordance with New York Village Law 5-508(3) the tentative Village Budget for the fiscal year commencing June 1, 2018 and ending May 31, 2019, a copy of which is available at the office of the Village Clerk where it may be inspected by any interested person during office hours. (Note: The compensation proposed to be paid to each member of the Board of Trustees is zero.)

NOTICE IS HEREBY GIVEN THAT copies of the proposed Local Laws, a copy of the 2018 – 2019 Tentative Budget and a copy of the Municipal Stormwater (MS4) Report described above are on file in the office of the Village Clerk of the Village of Lawrence, NY, where the same is available for public inspection during regular office hours.

PLEASE TAKE FURTHER NOTICE that all interested parties will be given an opportunity to be heard on said proposed Local Law at the place and time aforesaid. **If anyone needs special accommodations for a disability, such person should contact the Village Clerk at least 5 days before the public hearing.**

NOTICE IS HEREBY GIVEN, pursuant to the requirements of the Open Meetings Law of the State of New York, that the Board of Trustees of the Village of Lawrence will convene in public

meeting at the place and time aforesaid for the purpose of conducting a regular meeting where general business will be conducted, and for the purpose of conducting a Public Hearing on the proposed Local Law described above and, as deemed advisable by said Board, taking action on the enactment of said Local Law.
