### REGULAR MEETING

**Board Action:** Trustee Felder moved the approval to open the Regular meeting. Trustee Gottesman seconded the motion. All in favor.

Mayor Nahmias called the Regular Meeting to order at 8:00 p.m.

# Public Hearing #2 regarding the proposed Local Law of 2024 to amend the Village Code for Zoning

**Board Action**: This item was tabled/adjourned until the next BOT meeting, on October 10, 2024.

## PLEDGE OF ALLEGIANCE

Approval of minutes: BOT August 15, 2024

**Board Action:** Trustee Felder moved the approval of the August 15, 2024 BOT meeting minutes. Trustee Gottesman seconded the motion. Trustee Parnes recused himself, because he was not in attendance. All in favor.

### **GOOD & WELFARE**

- 1) Trustee Gottesman recognized and invited former Trustee and Deputy Mayor Paris Popack, as a courtesy, to open the floor for her to speak and/or ask any questions regarding concerns she may have that she would like to have the Board address. She responded that she did not.
- 2) Judi Bernstein of 54 Meadow Lane stated that the speeding on Broadway is an ongoing problem in the area. Her husband was walking from Herrick Drive to Meadow Lane (on Broadway) and stated that the drivers were "going 50 miles per hour". She added that there is a lot of speeding in this town and a lot of reckless driving in this town. Ms. Bernstein stated that she was almost hit twice and her husband was hit twice (by a car). With regard to the vehicular issues in Cedarhurst, Mayor Nahmias suggested that Ms. Bernstein reach out to Mayor Benjamin Weinstock and Deputy Mayor Ari Brown as well as attend one of their Board meetings. The Mayor added that he has spoken to Inspector Ciaccio and Lt. Sollin of the Fourth Precinct, trying to work towards a solution, so this is helpful to target more specific areas. Discussion ensued in this regard.
- 3) Rochelle Stern-Kevelson of 21 Causeway has reported that she would like the "No Turn on Red when Pedestrians are Present" sign to be changed to "No Turn on Red". She stated that many motorists do not observe the sign at all, making right as well as left turns on red. Ms. Kevelson added that there is shrubbery blocking the view for cars, as they turn, which is dangerous. Mayor Nahmias offered for Village staff to meet her so she can show the specifics she is referring to. Ms. Kevelson also requested speed humps on Causeway, to try to mitigate the speeding; and, once again, for the glass on the meters to be cleaned.

Discussion ensued and Mayor Nahmias concluded that we're going to try very hard to fix these issues. Ms. Kevelson thanked the Mayor.

- 4) Chaim Weiser of 209 Causeway (between Ocean Avenue and Barrett Road), raised an issue he had also brought to the prior Administration, echoing what has been discussed already - - the speeding issue. He supplied photographs and explained that when he moved into the neighborhood in 2019, Back Lawrence was more of a "sleepy hollow". Now, the community has a lot of children, no sidewalks in Back Lawrence, many large ongoing construction projects along with the aforementioned speeding and reckless driving. Mr. Weiser added that there is no stop sign between Barrett Road and Ocean Avenue (on Causeway, which is a long stretch of roadway and has a curve); there is only a stop sign on Narragansett Avenue, that is recessed and hard to see. He has seen very dangerous situations arise and would like the Village to put speed humps and perhaps stop signs on Causeway. Discussion ensued in this regard. The Mayor and Board expressed their willingness to help, but requested that Mr. Weiser get signatures from him neighbors all along the block, especially where he would like the stop signs and speed humps (with signage) placed, to mitigate any backlash as the Village has previously encountered.
- 5) Blanche Lerer of 2 Wentworth Place (at the corner of Broadway), has difficulty pulling out of her street even with the crosswalk/don't block the box signage and striping the Village installed. The Mayor and Board responded that this is an enforcement issue and they will be in touch with the Fourth Precinct. Ms. Lerer also reported two street lights out on Broadway, off of Lord Avenue, and one across from The Carlisle (near the Firehouse and Washington Avenue), which the Village will report tomorrow to have repaired. Ms. Lerer inquired if the late NYS Senator Carol Berman's house (which was sold and demolished), at the corner of Lord Avenue and Hards Lane, is zoned for a three-story house; which was not permitted "in her time". Discussion ensued regarding the changes in zoning codes since Super Storm Sandy, and flood zones.

## Item #7 - Approve Resolution to hire Tree Pruning Services not to exceed \$50,000

Mayor Nahmias explained that this is to kickstart a "Beautification Program" to get back to the roots (the fabric) of what our Village should look like. In addition, the DPW will be surveying the neighborhood, identifying areas where the shrubbery needs to be cut back off of the sidewalks; where trees need to be replaced/removed; as well as broken sidewalks requiring repair. Village Administrator Gerry Castro added that the Village will abide by the Village's Procurement Policy in the hiring of the Tree Pruning contractor; whatever course of action is necessary and with full transparency. Mayor Nahmias added that the Village is in the process of working with NYS Senator (the Honorable) Patricia Canzoneri-Fitzpatrick, who has a \$150,000.00 grant, ready for us to receive; to assist the Village in repairing the street lights on Route 878.

**Board Action:** Trustee Felder moved to approve a Resolution to hire Tree Pruning Services not to exceed \$50,000.00. Trustee Parnes seconded the motion. All in favor.

## Item #8 - Approve hiring of office staff for LY&CC

**Board Action:** Trustee Felder moved to approve the hiring of office staff for the LY&CC. Trustee Parnes seconded the motion. All in favor.

## Item #9 - Approve increase for Village Hall staff

Mayor Nahmias explained that this is actually a savings, not an expense. He went on to say that due to the resignation of one of the Village Hall staff in the Court, the Court Clerk to the Village Justice, who has been here for eighteen (18) years, and feels they can handle the work, will get an additional \$12,000.00 to do so. This will be an approximate savings of \$51,000.00; with the understanding (and transparency) that in the event that they can't handle the work, they won't get the additional \$12,000.00 and another staff member will be brought in. An Administrative staffer will also take on an increase in workload (to assist the Court Clerk) for a \$7,000.00 salary increase, pending the success of said "program". They Mayor added that it's a program to see if we can save money and was something that the Court Clerk wanted.

**Board Action:** Trustee Felder moved to approve an increase of \$12,000.00 for the Village Hall Court and a \$7,000.00 increase for Village Hall Administrative Clerical. Trustee Gottesman seconded the motion. All in favor.

On motion by Trustee Parnes, seconded by Trustee Felder and unanimously approved, the Board adjourned at 8:54 p.m.
