## Present NYCOM Certificates for Twenty-Five Years of Public Service

Mayor Nahmias explained that NYCOM issues an award (Certificate) when someone reaches twenty-five (25) years of service. The Mayor announced that he was pleased to present Village Treasurer Lina Fusco with such a Certificate, as well as Board of Zoning Appeals Chairman, Lloyd Keilson, who was not present at tonight's BOT meeting. There was a round of applause.

#### **GOOD & WELFARE**

1) Moshe Glenn of 61 Bayberry Road and the proprietor of MG Kraft Kitchen, LLC, stated that there have been some issues operating his establishment at the

LY&CC snack bar. Mr. Glenn stated that he brought in "an HVAC guy" and the Village brought in an engineer who gave a report on the various items. One of the options/suggestions was to clear the clutter in the back which was Mr. Glenn's responsibility, and has already been addressed/cleared. Mr. Glenn said that in addition, there were some air leak issues, which Mayor Nahmias confirmed and responded that the Village's DPW would indeed caulk and seal what they could; as well as the taking care of the HVAC issues, bringing them up to the proper standards. Mayor Nahmias added that this engineer kindly offered these diagnostic services for free, identified the problem (with the hood ventilation) and offered to repair it at his cost (approximately \$4,000 - \$5,000), if Mr. Glenn decides to go forward with this; which is at his discretion. Mr. Glenn raised the issue of cold air entering through the front door area and putting up some sort of barrier. Discussion ensued in this regard. This matter will be reviewed further by the appropriate parties, when a remedy is suggested by the engineer or other party.

#### Item #4 — LY&CC Status Report

LY&CC General Manager Kevin Dudleston thanked the Mayor and Board for the previous evening's Village Holiday party. He added that the staff enjoyed the party as well, and those who won raffle prizes were extremely happy. Mr. Dudleston went on to present the LY&CC GM Report for December 2024, attached hereto as Exhibit "D". He added that the LY&CC had a 30% net increase in revenues from last year. Village Treasurer Lina Fusco stated that the LY&CC bank accounts are now starting to increase; the Village doesn't have to "carry" the Club, whereas at the same time last year, the Village wrote large checks in October, November, December 2023; and January 2024. So, it's a marked improvement and "good"; and this is also prior to the Marina billing.

At the previous evening's January Park Advisory meeting, and the below item was discussed:

### GINGER BOOKVAR (NR BRONZE – Age Mid 80's) & JANEY ZUKERMAN (NR SILVER – Age Late 70's):

Both Members did not play Golf at all in 2024. They are long term members and were unable to use the club at all due to medical and personal reasons. Both have reached out to me to present to the board for any chance of a rollover of their dues in 2025. The Park Advisory Committee recommended that due to their loyalty and individual circumstances that they would only pay 50% of the 2025. This would mean that Janey would be charged \$2,998 and Ginger charged \$2,148 for 2025.

**Board Action:** Trustee Felder moved to approve the above Park Advisory Council's recommendation regarding Ginger Bookvar and Janey Zukerman paying 50% of their respective 2025 LY&CC memberships. Trustee Parnes seconded the motion. All in favor.

Mayor Nahmias explained that it's become abundantly clear that all of the Board members have busy schedules and are not always around, especially in light of upcoming vacations. In that vein, the Mayor appointed the four (4) Board members as Deputy Liaison Police Commissioners to the Nassau County Police Department (NCPD); to liaison with them in the event that there's a crime, or there's an emergency or there's a need for help in our community. The Mayor added that we love the work that the NCPD does, this just helps make sure that government coverage is here to communicate with them.

**Board Action:** Trustee Felder moved to approve the appointments of Deputy Mayor Roz, Trustee Parnes, Trustee Felder and Trustee Gottesman as Deputy Liaison Police Commissioners to the Nassau County Police Department. Trustee Parnes seconded the motion. All in favor.

A local law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-c					
Section 1. Legislative Intent					
It is the intent of this local law to allow the Village of <u>Lawrence</u> to adopt a budget for the fiscal year commencing <u>June 1, 2025</u> that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.					
Section 2. Authority					
This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.					
Section 3. Tax Levy Limit Override					
The Board of Trustees of the Village of <u>Lawrence</u> , County of <u>Nassau</u> , is hereby authorized to adopt a budget for the fiscal year commencing <u>June 1, 2025</u> that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.					
Section 4. Severability					

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.
